- 1. Rob Rutledge called the meeting to order and declared a quorum. Note: Michael Sheahan was given proxy for Board members Patrick Sheils and Sherille Layton.
- 2. MINUTES OF PRIOR ANNUAL MEETING, February 2, 2016
 - Submitted and moved by Michael and seconded by Dan that the minutes from the previous AGM be approved.

3. FINANCIAL STATEMENTS

- Michael reviewed the financial statements for the Association's fiscal year end (December 2016), copies of which were distributed to those in attendance and are available on the web site.

- Rob and Michael thanked Leanne for her contributions to the Association.

5. OTHER BUSINESS OR SPECIAL BUSINESS

- Michael provided an update on the status of the Spring Fair organization (permits, food, beer garden, possible games/events, volunteers). A call for more volunteers was requested. Mary Lord and Michael and Leanne will pursue the smart server designation.
- Rob provided an overview of the tremendous work done by Jaye Robinson, supported by the Association, to secure the city's purchase of the 100 Ranleigh property for public space. In that regard, he noted that the Association is hosting a victory party March 1 at the Uptown Pub to thank Jaye and to encourage community discussions on the new space.
